Purpose

The purpose of the NED Fee Sacrifice Plan is to:

- provide an opportunity for the NEDs to build their Securityholding in the Group and support NEDs meeting their minimum securityholding requirements;
- further align the NED interests with the interests of Securityholders; and
- assist the NEDs with the acquisition of Securities in compliance the Corporations Act 2001 (Cth) and the Mirvac Group Security Trading Policy.

Participation

Only NEDs who are members of the Mirvac Board can participate in this Plan.

Terms

NEDs may elect to sacrifice, on a pre-tax basis, up to 100% but no less than 10% of their fees, being the total of base director fees, inclusive of superannuation (Contribution).

Based on the Contribution that has been elected to be sacrificed and the Allocation Price for the relevant participation period (being the one-month volume weighted average price (VWAP) of a Security leading into the commencement of the trading window in which the grant of Rights will be made - expected to be on or around the release of half-yearly and full-year results), the number of Rights will be determined by dividing the participant Contribution that relates to the corresponding participation period by the Allocation Price for the Rights.
