

"Australian Open - Serving Up the Energy Play to Win" Terms & Conditions

Background to Competition

- Information on how to enter and prizes form part of these Terms and Conditions. Participation in this Serving Up The Energy' Play To Win 2025 (Competition) is deemed acceptance of these Terms and Conditions.
- 2. If there is any inconsistency between these terms and conditions and any other documents or information that refers to this Competition, these terms and conditions shall prevail.
- 3. The Competition is being offered by Collins Place. **Promoter** means Collins Place.
- 4. The Competition is open for a limited time. The Competition commences 11am on Monday 13 January 2025 and ends at 2:00pm Friday 24 January 2025 or until the prize pool is exhausted (Competition Period). The Competition will run Monday through to Friday 11am to 2pm daily during the campaign period. All references to time in these terms and conditions are a reference to AEST. All monetary amounts are expressed in Australian dollars (AUD), unless otherwise stated. Any entries received outside the Competition Period will not be accepted.
- 5. Subject to these terms and conditions, the Competition will be conducted at Collins Place (Participating Centre). The Participation Centre will be running a 'play to win' competition where customers can sign up as a Collins Place VIP to gain a single entry in to play the Collins Place Ticket Booth. Each entrant can also opt in to enter the participant into entering a one-night stay for two at Sofitel Melbourne on Collin.
- 6. The following terms and conditions apply to the **Competition**. Entry into the **Competition** is deemed acceptance of these terms and conditions. A reference to Mirvac or the Promoter in these terms and conditions includes, where appropriate, Mirvac's employees, officers, volunteers, agents and contractors.

Competition Terms and Conditions

Eligibility to enter the Competition

- Subject to paragraph 9, entry into the Competition is open to Australian permanent residents, aged 18 years and over (as at the date of entry) acting on their own behalf (Eligible Entrants).
- 8. Collins Place (**Mirvac**) reserves the right in its absolute and sole discretion to request the winner to provide proof of identity and proof of residency at the time of claiming the Prize.
- 9. The Competition is <u>not</u> open to:
 - a. businesses or companies, registered builders, superannuation funds or persons acting as agent on behalf of other persons;
 - b. directors, management, officers, contractors and employees of:
 - i. the Promoter,



- ii. the Prize Supplier (if different to the Promoter);
- iii. any person or entity involved in determining the winner; or
- iv. any other person, company, supplier or agency associated with the Competition or involved in the management of any benefiting business including of any prize provider;
- v. a spouse, de facto spouse, partner, guardian, parent, child, sibling (whether natural or by marriage or adoption) of any person referred to in sub-paragraph (b).

How to enter the competition

- 10. To enter the Competition, Eligible Entrants must, during the Competition Period:
 - a. Visit the Collins Place Ticket Booth in the forecourt
 - b. Scan the QR code and complete the official entry form including their full legal name, valid contact number, valid email address, valid postcode and subscribe to become a Collins Place VIP. Entrant must remain subscribed to the database until at least the date of draw or any re-draw to be eligible.
- 11. Multiple entries in the one day are not permitted. Limit of one (1) entry per day, per person in line with condition 11.
- 12. Eligible Entrants must disclose to Collins Place (Mirvac) any issues that may generate negative publicity and impact on the success of this Competition at the time of entering the Competition or as soon as the Eligible Entrant becomes aware of such issues.
- 13. Mirvac reserves the right to remove or disqualify an Eligible Entrant or their entry from the Competition if Mirvac, in its absolute discretion, deems that the entry is inappropriate or considers the Eligible Entrant's continued involvement in the Competition may negatively impact on the success of the Competition and/or negatively influence the general purpose of the Competition. No correspondence will be entered into.
- 14. It is a condition of participating in the Competition that Eligible Entrants agree to be interviewed, photographed or filmed by or on behalf of the Promoter and for their entry to be photographed, videoed and/or used for a story or feature on this Competition and to appear in print, digital, film or social media content (or any other form of media it deems suitable) on a royalty free basis for an unlimited period without remuneration or reference to the Eligible Entrant. Any story or feature (including creative control) will remain at the discretion of the Promoter at all times. Any story or feature does not create a relationship of employer and employee, principal and agent, partnership or joint venture or similar between the Eligible Entrant and the Promoter.

Drawing of the winner/s

- 15. Subject to availability (while stocks last), winning a prize will be determined by the participants chance of selecting a lucky number. Each eligible customer will have a chance to select a lucky number to win a prize.
- 16. Winners will only be eligible to claim prize if they have completed valid entry form within the opening hours. Any entries outside the opening hours will not be valid including entries for specific prizes.



- 17. Mirvac reserves the right to redraw in case of an invalid entry or invalid entrant. Mirvac's decision in relation to any aspect of the Competition will be final and binding on every person who enters. No correspondence will be entered into.
- 18. Mirvac will immediately notify the winner(s) by verbal confirmation at the Ticket Booth set. The winner(s) will have the winning prize handed to them immediately on the day. Any additional costs associated with redeeming the voucher prizes will be at the own expense of each entrant. Some prizes will require the participant to enter an email address for the prize to be emailed directly to the winner before or on Friday 31 January.

19. The total prize pool includes:

- 20. Unless otherwise expressly stated, Prize values are based on the recommended retail prices in Australian currency at the time of first publication of these terms and conditions (inclusive of GST). The Promoter does not accept responsibility for any change in the Prize value between now and the date the Prize is collected by the rightful winner.
- 21. Responsibility for supply of each element of the Prize lies solely with the Promoter. Each other entity comprising the Promoter is not responsible for supply of the relevant element of the Prize.
- 22. The Prize (or any element of it) may not, without the prior written consent of the prize supplier and the Promoter, be resold or offered for resale at a premium (including via online auction sites) or used for advertising, promotion or other commercial purposes (including competitions and trade promotions) or to enhance the demand for other goods or services. If the Prize or any part thereof is sold or used in breach of this condition, the Promoter and/or the Prize Supplier may, in their absolute discretion, withdraw the Prize or any element of it. Where a Prize or element has been withdrawn in accordance with this paragraph, no refund, substitute or compensation will be offered.

- 24. The Prize(s) are non-transferrable, non-refundable and, to the extent that it comprises of noncash elements, cannot be exchanged for cash. All taxes which may be payable as a consequence of receiving or participating in the Competition or receiving the Prize are the sole responsibility of the winner.



- 25. If the Prize or any element of the Prize becomes unavailable for reasons beyond the Promoter's control, then the entity responsible for the relevant element of the Prize may substitute a prize or element of a prize of equal or greater value at that entity's sole discretion, subject to any written directions from any relevant authorities. The winner will not be entitled to any compensation in the event that the Prize or any element of the Prize has been substituted at equal or greater value.
- 26. Eligible Entrants forfeit all rights to receiving the Prize(s) or participate in the Competition if an Eligible Entrant does not comply with any of these terms and conditions.

Further Terms and Conditions of Competition

- 29. Failure by the Promoter to enforce any of its rights under these terms and conditions does not constitute a waiver of those rights.
- 30. To the extent permitted by law, the Promoter is not liable to the Eligible Entrant for any loss or damage, any personal injury or death or negligence, whether direct, indirect, consequential, exemplary, incidental, special or punitive (including loss of opportunity and loss of profit) suffered, sustained or arising out of or in connection with the Eligible Entrant's participation in this Competition, the Prize (or any element thereof) and/or use of the Prize (or any element thereof) notwithstanding that the Promoter may have been advised of the possibility of such loss or damages.
- 31. As between the Promoter and each individual Eligible Entrant, these terms and conditions are governed by the laws of the State or Territory in which the Eligible Entrant entered this Competition (being either QLD, NSW, VIC or ACT).
