

South Eveleigh Summer Club Merchandise Giveaway 2024 Terms and Conditions

Background to Competition

- Information on how to enter and prizes form part of these Terms and Conditions. Participation in the South Eveleigh Summer Club Merchandise Giveaway (Giveaway) is deemed acceptance of these Terms and Conditions.
- 2. If there is any inconsistency between these terms and conditions and any other documents or information that refers to this Competition, these terms and conditions shall prevail.
- 3. The Competition is being offered by South Eveleigh. **Promoter** means South Eveleigh.
- 4. The Competition is open for a limited time. The Competition commences 010:00AM on Monday 2nd December 2024 and ends at 04:00PM on Saturday 14th December 2024 (Giveaway Period). All references to time in these terms and conditions are a reference to AEST. All monetary amounts are expressed in Australian dollars (AUD), unless otherwise stated. Any entries received outside the Competition Period will not be accepted.
- 5. Subject to these terms and conditions, the **Competition** will be conducted at South Eveleigh, (**Participating Centre**). The **Participating Centre** will be running a spend to win giveaway where:

a) Customers who spend \$10 or more at participating South Eveleigh retailers can bring their receipt to the Summer Club Kiosk and redeem for one (1) piece of daily merchandise. The first 120 - 135 (one hundred and twenty – one hundred and thirty five) customers to do so will receive a piece of merchandise, depending on the quantities each day as described in paragraph 15 & 18.

Competition Terms and Conditions

Eligibility to enter the Competition

- Subject to paragraph 10, entry into the Competition is open to both Australian and International students only, aged 18 years and over (as at the date of entry) acting on their own behalf (Eligible Entrants).
- 7. South Eveleigh (**Mirvac**) reserves the right in its absolute and sole discretion to request the winner to provide proof of identity and/or proof of residency at the time of claiming the Prize.
- 8. Incomplete, indecipherable or illegible entries will be deemed invalid. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 9. The Competition is <u>not</u> open to:

- a. businesses or companies, registered builders, superannuation funds or persons acting as agent on behalf of other persons;
- b. directors, management, officers, contractors and employees of:
 - (i) the Promoter,
 - (ii) the Prize Supplier (if different to the Promoter);
 - (iii) any person or entity involved in determining the winner; or
 - (iv) any other person, company, supplier or agency associated with the Competition or involved in the management of any benefiting business including of any prize provider;
- c. a spouse, de facto spouse, partner, guardian, parent, child, sibling (whether natural or by marriage or adoption) of any person referred to in sub-paragraph (b).

How to enter the Competition

- 10. To enter the **Competition**, Eligible Entrants must, during the **Competition Period**:
 - a. Spend \$10 or more at participating South Eveleigh retailers and bring their receipt to the Summer Club Kiosk and redeem for one (1) piece of daily merchandise.
- 11. Eligible Entrants may enter the giveaway once per day.
- 12. Eligible Entrants must disclose to South Eveleigh (Mirvac) any issues that may generate negative publicity and impact on the success of this Competition at the time of entering the Competition or as soon as the Eligible Entrant becomes aware of such issues.
- 13. Mirvac reserves the right to remove or disqualify an Eligible Entrant or their entry from the Competition if Mirvac, in its absolute discretion, deems that the entry is inappropriate or considers the Eligible Entrant's continued involvement in the Competition may negatively impact on the success of the Competition and/or negatively influence the general purpose of the Competition. No correspondence will be entered into.
- 14. It is a condition of participating in the Competition that Eligible Entrants agree to be interviewed, photographed or filmed by or on behalf of the Promoter and for their entry to be photographed, videoed and/or used for a story or feature on this Competition and to appear in print, digital, film or social media content (or any other form of media it deems suitable) on a royalty free basis for an unlimited period without remuneration or reference to the Eligible Entrant. Any story or feature (including creative control) will remain at the discretion of the Promoter at all times. Any story or feature does not create a relationship of employer and employee, principal and agent, partnership or joint venture or similar between the Eligible Entrant and the Promoter.

Drawing of the winner

4:00PM between Monday 2nd December – Saturday 14th December, or until all units are exhausted.

The first 120 – 135 customers (depending on the quantities of merchandise available per day) who spend \$10 or more at participating South Eveleigh retailers can redeem their receipt for a piece of Summer Club merchandise. Mirvac reserves the right to redraw in case of an invalid entry or invalid entrant. Mirvac's decision in relation to any aspect of the Competition will be final and binding on every person who enters. No correspondence will be entered into.

- 16. Mirvac will notify the winner immediately if they are successful in the Summer Club Merchandise 20204 Giveaway. Any winner will only be deemed a winner once verified by the Promoter. The winner(s) will have the winning prize given to them immediately at The Kiosk.

- 19. The Promoter does not accept responsibility for any change in the Prize value between now and the date the Prize is collected by the rightful winner.
- 20. Responsibility for supply of each element of the Prize lies solely with the **Promoter.** Each other entity comprising the Promoter is not responsible for supply of the relevant element of the Prize.

- 21. The Prize (or any element of it) may not, without the prior written consent of the prize supplier and the Promoter, be resold or offered for resale at a premium (including via online auction sites) or used for advertising, promotion or other commercial purposes (including competitions and trade promotions) or to enhance the demand for other goods or services. - 30. As between the Promoter and each individual Eligible Entrant, these terms and conditions are governed by the laws of the State or Territory in which the Eligible Entrant entered this Competition (being either QLD, NSW, VIC or ACT).
